

- No environmental incidents reported.




#### **Environment**




### SMP Update – Area 1 & 2

- Weekly TransGrid surveys and reports (including real time monitoring on the 330kV TransGrid Transmission Towers)
- Notification provided to DTIRIS regarding Tilt Meters (shooting incident)
- Ausgrid, TransGrid, Blackhill Road monthly reports completed
- End of Year SMP report completed
- Panel 20 SMP compliance audit submitted to DTIRIS.
- SMP Area 2 Variation was submitted and approved by DTIRIS (Panel 22 extra heading)
- Mining completed in C&A (Black Hill Land) subsidence surveys being conducted to confirm effective subsidence has been completed
- 1 Month notification of commencement of extraction letters sent out as per PSMP's to 3 landowners
- Demolition of catholic derelict buildings continues.




### **SMP Area 1 Variation**

- Commenced Premining property inspections and Dam surveys/assessment for DMMS as per PSMP process




