6.1 Development update

6.1.1 Abel Program 2013 – Mr Charlie Spence (Refer to attached presentation). Mr Terry Lewin asked about the Duncan mining method. Mr Charlie Spence stated that it

reduced subsidence and lead to faster production, but reduced recovery rates. Mr Terry Lewin asked why extraction production rates had increased. Mr Charlie Spence attributed this to the downturn, which had resulted in increased motivation amongst the

workforce. Mr Allan Jennings asked about how long the downturn was expected to last. Mr Charlie Spence stated that any comment he made would be speculation.

Mr Alan Brown asked about the port arrangements. Mr Charlie Spence stated that coal was moved through both PWCS and NCIG operations.

6.6 SMP Update

Mr Tony Sutherland (Refer to attached presentation).

Mr Allan Jennings questioned the use of signage on the already degraded Blackhill road and stated that the community could incorrectly attribute the existing degradation to mining operations. Mr Tony Sutherland stated that it might be possible to attempt to inform residents that mining had only just entered the area and that the degraded condition of Blackhill road predated mining.

Mr Allan Jennings asked how many Property Management Plans had been completed. Mr Tony Sutherland stated that seven had been completed.

Mr Terry Lewin asked about a recent community information session. Mr Phillip Brown stated that the attendance had exceeded expectations, the general response was positive and that the map showing the planned timing of mine progress was appreciated.

- **7.1.7** Reconcile the claimed tonnage benefit from longwall/shortwall compared with original estimates, 4.5 to 6.1 Mtpa. Mr Tony Sutherland stated that the modification will enable extraction of additional seam components.
- **7.1.8** Community members have requested that community information sessions be followed up with individual QA sessions. Mr Tony Sutherland stated that this could be possible.
- **7.1.9** Can we have a copy of the chairman's CCC Annual Report to Director General of the DPI? Mr Phillip Brown stated that the report could be requested.
- **7.1.10** Is there a summary status of Consent Conditions compliance? Mr Phillip Brown stated that this was provided in the annual report to the DoP.
- **7.1.11** Can the members who have been consistently absent from meetings be removed from the CCC? Mr Phillip Brown stated that he would discuss this with the chairman upon his return.
