   This coincided with a test and review of the Abel Pollution Incident Response Management Plan.




#### **Environmental Update**

- Abel has recently submitted the Environmental Protection Licence Annual Review to the EPA.






# **Dust Deposition**








# Abel PM10 Monitoring




# pH Monitoring






# **Electrical Conductivity Monitoring**






## **Total Suspended Solid Monitoring**

#### Rainfall






#### **Property Update**

- New fencing planned to be installed along John Renshaw Dr in coming months.





- a study of Blue Gum Creek Catchment to assess the level of contamination of water hyacinth and prepare a management plan to eradicate address the hyacinth
- Flora Assessment of the RVRT by Callum Vizer
- Trust contribute \$5,000 towards a biodiversity day
- provide financial support to assist with the preparation of the Environmental Impact Statement (EIS)
   up to the value of \$175,000 for the RVTR
- December 2014, the DCT provided \$7,200 for an independent aquatic weed survey for Pambalong
- \$20,000 to support an ecological and ecotourism assessment of the Richmond Vale Railway was funded by the Trust.
- agreed to support the research proposal of The Tom Farrell Institute for the Environment, University of Newcastle, for 2 years. The project was to develop over two years, a research and education program that would deliver sustainable conservation and biodiversity initiatives and sustainable development, including ecotourism, in the 10,000 hectares of the DCT area.
- Agreement with NPWS Midtrail Precinct For several years, DCT's activities have been consolidated around themes related to the proposed Richmond Vale Rail Trail (RVRT). The Project to be funded by this Agreement is consistent with the Trust Objectives and with DCT's overarching goal to jointly enhance and promote conservation-oriented integrated regional development of the RVRT and the Stockrington SCA.
